JUDGEMENT

K. M. G. H. KULATUNGA, J.

1. 394 petitioners in this application, *inter alia*, are seeking writs of prohibition and *mandamus* as follows:
 - a. by prayer (c), grant and issue a mandate in the nature of a writ of prohibition prohibiting the respondents and/or any other person working under the respondents from recruiting and/or appointing any other person and/or persons other than the petitioners to the post of Archaeological Assistant and Watcher in the Department of Archaeology; and
 - b. by prayer (d), grant and issue a mandate in the nature of a writ of *mandamus* directing all and/or several and/or one of the respondents to reinstate the petitioners in service in the posts they held in the Central Cultural Fund or Archaeological

Department as per documents annexed to P-1 to P-394 and to make the said appointments of the petitioners permanent in terms of the Public Administration Circulars 25/2014 and 29/2014.

2. This matter was taken up for argument on 29.07.2025. Upon so concluding, post-argument written submissions were tendered on 09.10.2025 and 20.11.2025, respectively. Then, a motion dated 29.08.2025 was also filed on behalf of the 1st, 3rd, 6th, and 7th respondents, along with which the marksheets of the interviews held in 2019 were tendered as X-1 and X-2.

Facts.

3. These petitioners were initially recruited for the posts of Archaeological Assistants (labourers) on the approval of the Board of the Central Cultural Fund (“the CCF”). The said recruitment, according to the Letters of Appointment, was contractual in nature initially for a period of one year. The several petitioners were so appointed on three different occasions as follows:
 - i. 1st to 337th petitioners, with effect from 23.11.2017;
 - ii. 338th to 387th petitioners, with effect from 01.05.2018; and
 - iii. 338th to 394th petitioners, with effect from 14.02.2019.

It is the position of the petitioners that the periods of contract were subsequently extended. The said extensions lapsed as follows:

- i. 1st to 337th petitioners, until 01.02.2020;
- ii. 338th to 387th petitioners, until 01.05.2020; and
- iii. 338th to 394th petitioners, until 14.02.2020.

Accordingly, the 1st to the 337th petitioners have been serving on such contractual basis for approx. 2 years and 3 months, the 338th to the 387th petitioners for 2 years, and the 338th to the 394th petitioners for 1 year. The petitioners claim that according to clause 12 of the initial

Letters of Appointment, there was an intimation to the effect that the petitioners will be absorbed into the Department of Archaeology subject to relevant approvals. The said clause reads as follows:

“පුරාවිද්‍යා දෙපාර්තමේන්තුව මගින් කළමනාකරණ සේවා දෙපාර්තමේන්තුවට ඉදිරිපත් කර ඇති මෙම තනතුරු අනුමත වීමෙන් අනතුරුව යථා කාලයේ දී ඔබ පුරාවිද්‍යා දෙපාර්තමේන්තුවට අනුයුක්ත කිරීමට නියමිතය.”

4. According to the respondents, these recruitments on contractual basis were necessitated in order to safeguard the archaeological sites across the island, and in view of the urgency, they were so recruited on contractual basis. Recruitments on this basis had been made as there had not been cadre approval to accommodate the required number of employees at that point. To meet this exigency and due to the urgency, the 1st respondent, the CCF, has agreed to recruit the petitioners on such contract basis and assign them to the Department of Archaeology (*vide* R-1 and R-2). It is thus admitted and conceded by the respondents that the petitioners were employed on such contractual basis. However the respondents claim that it was strictly on such basis for a specific time period. The respondents also concede that such contracts initially granted were in fact extended in respect of two categories of petitioners referred to in paragraph 03 above.

5. The position of the respondents is that, at all material times, the petitioners were employees of the CCF. Thereafter, with the approval of the Director General of the Department of Management Services, cadre positions for 865 Archaeological Assistants and 1,000 watchers were approved within the Department of Archaeology (*vide* 4R-4). Then, by public notice dated 03.04.2019, applications were called for to fill these vacancies. The petitioners submit that, by letter P-2, dated 21.11.2018, an intimation was made that the said vacancies and positions would be filled by the Department of Archaeology, following the due interview procedure. It is thus common ground that applications were called for by P-3(1) on 03.04.2019, which was on an open competitive basis. The

petitioners admit having applied in response to the said notice for the said positions so published.

6. All the 6400 applicants have accordingly been interviewed in 2020. The petitioners allege that for five years, the said marks were not made available, including to the petitioners, and that there was no communication. It is their position that the purported marks were tendered to this Court by way of a motion dated 03.09.2025. The said list, containing the details of the applicants who obtained the cut-off mark for the respective two posts, was so made available as X-1 and X-2, by motion dated 29.08.2025. The petitioners allege that the said priority lists do not contain and/or comprise the entire mark sheet in detail and thus claim to be prejudicial to the petitioners. These lists contain only those who obtained the cut-off mark.
7. That being so, the primary argument of the petitioners is that the petitioners have a legitimate expectation arising from clause 12 of their initial Letters of Appointment, and the failure to make available the mark sheets since 2020 has caused further prejudice, and this has resulted in the continuity and prolonging of the legitimate expectation of the petitioners.
8. As opposed to this, the position of the respondents, basically, is that the petitioners' initial letters were issued by the CCF, which was purely of a contractual nature with the CCF and does not create a legitimate expectation in the petitioners to be absorbed into the permanent cadre of the Department of Archaeology.
9. The respondents also rely on the Management Services Circular No. 2 of 2020 (5R-2), which, by para 2 (*viii*), stipulates that the recruitment to the Primary Grade should be carried out exclusively by the newly established Multi-Purpose Development Task Force. Then, para 2 (*ix*) has reiterated the suspension of recruitment of the said grade by Management Services Circular No. 1 of 2020 (5R-1).

10. Then, in the course of the arguments on 29.07.2025, the learned State Counsel did submit that the Department of Archaeology has recruited 263 Watchers and 816 Archaeological Assistants, both under Grade PL(1) from the Multi-Purpose Development Task Force during the period 01.09.2023 to 28.05.2024. It was also submitted that as at 30.06.2025, a total of 1,114 vacancies in the PL(1) Grade, comprising of 293 Archaeological Assistants and 821 Watchers were available at the Department of Archaeology. It is the position of the petitioners that the said recruitments have been made in total disregard of and undermining the legitimate expectation of the petitioners. It is also averred in the written submissions of the petitioners that a considerable number of such vacancies have already been filled through external recruitment, without affording the petitioners priority or a fair opportunity for consideration. Accordingly, the learned President's Counsel for the petitioners submits that, still for all, there is a sufficient number of vacancies to accommodate all the petitioners, even at this juncture.
11. It is common ground that the petitioners have applied for the respective posts and faced an interview in or around 2020. The priority list based on the cut-off mark of 45 had been made available, marked X-1. However, due to an intervening Circular 01/2020, all recruitments had been suspended. In this backdrop, though interviews were so held and a priority list compiled, no recruitments were in fact made based on the same.
12. Accordingly, the position of the respondents is:
- a. that the petitioners are not entitled to any relief arising from the abandoned recruitment process, as its abandonment has not been challenged and no relief has been sought in that regard;
 - b. that the petitioners cannot have a legitimate expectation to be appointed to the posts merely by participating in the recruitment process;

- c. that paragraph 12 of the letters of appointment does not/cannot give rise to a legitimate expectation of permanent employment within the Department of Archaeology;
- d. that the petitioners do have a legal right enforceable in public law to be reinstated to service in terms of the letters of appointment marked P1 – P394; and
- e. that the Public Administration Circulars marked P-4(i) and P-4(ii) are not applicable to the petitioners' circumstances.

13. In view of Circular No. 01/2020 (5R-1), the interview process and recruitments were all stalled and suspended. There onwards, recruitments for the Primary Grades (PL(1), PL(2) and PL(3)) in all government public institutions were suspended. Then, by virtue of Circular No. 02/2020 (5R-2), such recruitments to the Primary Grade was carried out exclusively through the newly established Multi-Purpose Development Task Force. In these circumstances, the petitioners who were successful in the 2020 interviews were not issued with the interview results or marks. The entire process was suspended. In the interim, the periods of contract of the petitioners were all determined with the lapse of time.

Consideration of the application.

14. As submitted by the learned State Counsel, it appears that, long thereafter, direct recruitments have been made from the Multi-Purpose Development Task Force and certain of the vacancies have now been filled. The issue for determination is whether the petitioners have a legitimate expectation to be appointed or recruited to the said vacancies on a permanent basis. At this juncture, it is necessary to refer to the relief sought by prayer (d). The learned State Counsel argues that the relief sought is for reinstatement, and it cannot be granted. The argument is that a reinstatement sought is based on the abandoned process of recruitment, and the petitioners have not challenged the said abandonment. However, on a careful and close perusal of prayer (d) it is

apparent that the petitioners have sought to be reinstated in service in the posts they held under P-1 to P-394 (as per the original letters of appointment and contract). However, the said relief also seeks writs of *mandamus* directing the respondents to make the said appointments of the said petitioners permanent in terms of the Public Administration Circulars marked P-4(i) and P-4(ii). These two Circulars provide for the appointment and/or making permanent those who hold certain posts on a contractual basis. The relevant portion, from P-4(ii), are as follows:

“තාවකාලික, අනියම් (දෛනික), ආදේශක, කොන්ත්‍රාත් හෝ සහන පදනම මත බඳවාගෙන ඇති සේවකයින් සඳහා ස්ථිර පත්වීම් ප්‍රදානය කිරීම

01. 2016.04.04 දිනැති රාජ්‍ය පරිපාලන චක්‍රලේඛ 25/2014(ii) මගින් අවලංගු කරන ලද ඉහත කරුණ හා සම්බන්ධව නිකුත් කර ඇති 2014.11.12 දිනැති රාජ්‍ය පරිපාලන චක්‍රලේඛ 25/2014 හා 2014.12.29 දිනැති රාජ්‍ය පරිපාලන චක්‍රලේඛ 25/2014(i) කෙරෙහි අවධානය යොමු කරවමි.
02. ඉහත 25/2014 හා 25/2014(i) දරන රාජ්‍ය පරිපාලන චක්‍රලේඛයන්හි සඳහන් සුදුසුකම් සම්පූර්ණ කළ යුතු දිනය 2019.09.01 ලෙස සලකා එදිනට සුදුසුකම් සම්පූර්ණ කර ඇති නිලධරයන් එදින සිට මෙහි පහත සඳහන් i හා ii කොන්දේසි වලට යටත්ව ස්ථිර කිරීමට හැකිවන පරිදි රාජ්‍ය පරිපාලන චක්‍රලේඛ 25/2014 හා 25/2014(i) යළි බලාත්මක කිරීමට 2019.09.17 දින පැවති අමාත්‍ය මණ්ඩල රැස්වීමේ දී තීරණය කර ඇත.
 - i. ඉහත පරිදි ස්ථිර පත්වීම් ලබා දීමෙන් අනතුරුව විශ්‍රාම වැටුප් ව්‍යවස්ථා සංග්‍රහය යටතේ විශ්‍රාම වැටුපක් සඳහා සම්පූර්ණ කළ යුතු අවශ්‍යතා සම්පූර්ණ කළ හැකි නිලධරයන් සඳහා ස්ථිර විශ්‍රාම වැටුප් සහිත පත්වීම් ලබා දීම.
 - ii. ඉහත i හි සඳහන් අවශ්‍යතා සම්පූර්ණ කළ නොහැකි නිලධරයන් සඳහා රාජ්‍ය සේවක අර්ථසාධක අරමුදල යටතේ ස්ථිර පත්වීම් ලබාදීම.
03. ඉහත පරිදි ක්‍රියාකිරීමට අදාළ පත්කිරීමේ බලධරයන් ක්‍රියා කළ යුතු ය.
04. මෙම චක්‍රලේඛය මහා භාණ්ඩාගාරයේ එකඟතාව ඇතිව නිකුත් කරන ලදී.”

To that extent, the argument of the learned State Counsel is misconceived and is not convincing. The petitioners are, in fact, seeking that they be appointed to the vacancies in respect of the relevant posts referred to in P-1 to P-394.

15. To this end, the petitioners are basing their right and entitlement primarily on legitimate expectation. Prof. Craig, in ‘Administrative Law’

(7th Ed., at p.677), defines procedural and substantive legitimate expectation as follows:

*“The phrase ‘**procedural legitimate expectation**’ denotes the existence of some process right the applicant claims to possess as the result of a promise or behaviour by the public body that generates the expectation..... The phrase ‘**substantive legitimate expectation**’ captures the situation in which the applicant seeks a particular benefit or commodity, such as a welfare benefit or a license, as the result of some promise, behaviour or representation made by the public body.”*

The ideology of ‘substantive’ legitimate expectation originated in the landmark case of **R vs. Ministry of Agriculture Fisheries and Food, ex parte Hamble (Offshore) Fisheries Ltd** (1995) 2 All ER 714, where Sedley, J., held as follows:

*“Legitimacy in this sense is not an absolute. It is a function of expectations induced by government and of policy considerations which militate against their fulfilment. The balance must in the first instance be for the policy maker to strike; but if the outcome is challenged by way of judicial review, I do not consider that the Court’s criterion is the bare rationality of the policy maker’s conclusion. While policy is for the policy-maker alone, the fairness of his or her decision not to accommodate reasonable expectations which the policy will thwart remains the Court’s concern (as of course the lawfulness of the policy). **To postulate this is not to place the judge in the seat of the Minister...but it is equally the court’s duty to protect the interests of those individuals whose expectation of different treatment has a legitimacy which in fairness outtops the policy choice which threatens to frustrate it.**” [emphasis added].*

16. The abovementioned dictum of Sedley, J. has been cited with approval in the Sri Lankan decisions of **Dayaratne vs. Minister of Health and Indigenous Medicine** (1999) 1 SLR 393, in **Nimalsiri vs. Fernando** (SC/FR/256/2010, decided on 17.09.2015), and in **M. R. C. C. Ariyaratne and others vs. Inspector General of Police and others** (SC/FR/444/2012, decided on 30.07.2019). In **M. R. C. C. Ariyaratne and others vs. Inspector General of Police and others** (supra), Prasanna Jayawardena, P.C., J., after an extensive and all-

encompassing analysis on the doctrine of legitimate expectation, cited with approval the following dicta of Dehideniya, J.'s decision in **Zamrath vs. Sri Lanka Medical Council** (SC/FR/119/2019, decided on 23.07.2019), as the rationale underlying the doctrine of legitimate expectation:

“The legitimate expectation of a person ... further ensures legal certainty which is imperative as the people ought to plan their lives, secure in the knowledge of the consequences of their actions. The perception of legal certainty deserves protection, as a basic tenet of the rule of law which this court attempts to uphold as the apex court of the country. The public perception of legal certainty becomes negative when the authorities by their own undertakings and assurances have generated legitimate expectations of people and subsequently by their own conduct, infringe the so generated expectations.”

17. In **R. vs. North and East Devon Health Authority, ex p Coughlan** [2001] QB 213, Lord Woolf, M.R. (giving the judgment of the Court consisting of himself, Mummery and Sedley L.JJ.), as follows:

*“Where the court considers that **a lawful promise or practice** has induced a legitimate expectation of a benefit which is substantive, not simply procedural, authority now establishes that here too the court will in a proper case decide whether to frustrate the expectation is so unfair that to take a new and different course will amount to an abuse of power.”* [emphasis added.]

The above dicta confirms that an erroneous decision cannot create a legitimate expectation. Further, in **Siriwardane vs. Seneviratne and four others** [2011] 2 SLR 1, Dr. Shirani Bandaranayake, J. (as her Ladyship then was), held as follows:

*“A careful consideration of the doctrine of legitimate expectation, clearly shows that, whether an expectation is legitimate or not is a question of fact. This has to be decided not only on the basis of the application made by the aggrieved party before court, but also **taking into consideration whether there had been any arbitrary exercise of power by the administrative authority in question.**”* [emphasis added.]

18. Being mindful of the aforesaid, I will now consider if clause 12 of the letters P-1 to P-394 creates a legitimate expectation. This clause certainly does hold out that upon the approval of the said posts by the Department of Management Services, the petitioners are due to be attached to the Department of Archaeology in due course. This is a clear holding out that at some point in time, upon the cadre approval, the petitioners will be attached to the Department of Archaeology. The determinate factor specifically referred to therein is the approval of the said posts by the Department of Management Services. The learned State Counsel argues that this is a mere information and not a promise of permanent employment.
19. The plain reading of the said clause simply means what it says, and that's no more and no less than that the attachments will be made to the Department of Archaeology upon the realisation or receiving of cadre approval. These petitioners have been appointed on contract basis to two specific posts. The cadre approval was to be obtained in the future. When the petitioners are informed that attachment would be made with the approval, that means that they will be so appointed. This certainly creates an expectation, and as it is based on a lawful basis, to my mind, it is legitimate *per se*.
20. I will now consider if the sequence of events that is common ground between the parties in fact is sufficient to create such a legitimate expectation. The starting point is the initial letters of appointment, P-1 to P-394. The petitioners have been serving between 1 – 3 years in such posts and positions. The learned State Counsel does inferentially argue that the said letters of appointment were not given by the Department of Archaeology, but the CCF. The argument is that in the absence of any direct holding out, promise, or representation by the Department of Archaeology, the petitioners cannot have a legitimate expectation which would bind the Department of Archaeology. To this end, I observe that 4R-1 is relevant. This is a letter written by the Director General of the

Department of Archaeology, dated 04.09.2017, to the Director General of the CCF. Paragraphs 1 and 4 read as follows:

“01. ගරු අධ්‍යාපන අමාත්‍යතුමාගේ ප්‍රධානත්වයෙන් සහ අමාත්‍යාංශ ලේකම්තුමාගේ සහභාගීත්වයෙන් පැවති ප්‍රගති සමාලෝචන රැස්වීමේදී ශීර්ෂගත කරුණ සම්බන්ධයෙන් තීරණය කළ පරිදි පුරාවිද්‍යා ස්ථාන සඳහා ඔබ ආයතනය මගින් සේවකයින් බඳවා ගැනීමෙන් පසු පුරාවිද්‍යා දෙපාර්තමේන්තුව වෙත අනුයුක්ත කිරීමට තීරණය කරන ලදී.

...

04. ඔවුන් පසු කාලයක දී පුරාවිද්‍යා දෙපාර්තමේන්තුවට අන්තර්ග්‍රහණය කර ගැනීමේ හැකියාව පිළිබඳව කාර්යය මණ්ඩල තොරතුරු කළමනාකරන සේවා දෙපාර්තමේන්තුව වෙත ඉදිරිපත් කරනු ලබන හෙයින් මෙයට අමුණා ඇති බඳවා ගැනීමේ පටිපාටියේ සුදුසුකම් ලත් අය පමණක් බඳවා ගැනීමට කටයුතු කිරීම සුදුසු වේ.”

21. According to which, the Director General of Archaeology has informed that upon a discussion held with the Minister and the Secretary, it has been decided that the persons who may be recruited to the CCF, upon being so recruited, would be attached to the Department of Archaeology. Further it has also been stated by the Director General, in no uncertain terms, that the said recruitments to the CCF be made in accordance with the scheme of recruitment of persons with the requisite qualifications, as such persons are due to be absorbed to the Department of Archaeology. This, as I see, is a clear holding out by the Director General of Archaeology that, in fact, the petitioner, in due course, would be absorbed.

22. The use of the words ‘attach’ (‘අනුයුක්ත’) and ‘absorb’ (‘අන්තර්ග්‍රහණය’) in this letter is very significant and relevant. ‘Attach’ is defined in the Black’s Law Dictionary (8th Ed.) as follows:

“attach vb. 1. To annex, bind or fasten.”

As for attachment in the context of employment, it will mean that upon the recruitment to the CCF, such persons will, at some point, be annexed to or taken over by the Department of Archaeology. Then, the word ‘absorption’, used in paragraph 4, clearly establishes that the future attachment to the Department of Archaeology goes beyond a mere ‘appointment’. An appointment will contemplate a form of employment

in the first instance. However, 'absorption' will presuppose some form of appointment with one agency (the CCF) that would be regularised within the Department of Archaeology, which would contemplate a form of merger between the employment in the CCF and the Department of Archaeology. According to the Black's Law Dictionary (8th Ed.), 'absorption' is defined as follows:

*“**absorption** n. **1.** The act or process of including or incorporating a thing into something else. ... **3.** Labor Law. In a postmerger collective-bargaining agreement a provision allowing seniority for union members in the resulting entity.”*

Such attachment and absorption may then entail or require the issuance of a formal letter at that point, which will intimate the said attachment and absorption.

23. Next, the Board Paper 4R-2A, bearing No. 204.12.1, becomes relevant. The subject of this Board paper is the recruitment of watchers and labourers for the archaeological sites and the protection of archaeological artefacts. This Board Paper confirms that which is stated in paragraphs 1 and 4 of 4R-1. The said Board Paper specifically provides that these recruitments are specifically until the approval of the cadre of the Department of Archaeology. Similarly, the Director General of Archaeology has, by 4R-4, once again intimated that the proposed cadre increase had been approved, and as there may be a delay in recruitment, the period of contract of the labourers and watchers, who were recruited by the CCF, be extended. In this backdrop, in 2019, interviews have been called for to fill in the vacancies for the posts of Archaeological Assistants and Watchers in the Department of Archaeology. It appears that the petitioners have submitted themselves to the said interviews. The mark sheet of the candidates who secured the required cut-off mark was tendered to this Court marked X-1 and X-2. According to which, 98 petitioners have been successful in obtaining the cut-off mark. The said petitioners are the 1st, 18th, 21st, 43rd, 49th, 50th, 58th, 60th, 61st, 63rd, 65th, 66th, 79th, 80th, 81st, 84th, 91st,

94th, 99th, 104th, 107th, 120th, 121st, 125th, 126th, 127th, 133rd, 142nd, 148th, 151st, 152nd, 155th, 156th, 157th, 158th, 160th, 169th, 171st, 175th, 180th, 183rd, 188th, 194th, 196th, 199th, 200th, 208th, 209th, 215th, 216th, 217th, 218th, 220th, 227th, 231st, 233rd, 235th, 247th, 251st, 253rd, 256th, 258th, 261st, 267th, 269th, 273rd, 279th, 285th, 286th, 290th, 292nd, 294th, 295th, 296th, 302nd, 306th, 315th, 316th, 317th, 322nd, 323rd, 336th, 337th, 341st, 342nd, 344th, 345th, 347th, 348th, 350th, 353rd, 354th, 356th, 364th, 366th, 384th, 386th, and 390th petitioner.

24. It is upon the said interviews by a circular dated 21.02.2020, bearing No. 1/2020, the Ministry of Finance and Policy Development has made a general directive in respect of recruitments to the State, as well as to State Institutions, by which all recruitments will continue to be suspended. Paragraph 2 of the said Circular specifically provides that all recruitments to categories PL-1, PL-2, and PL-3 would continue to be suspended. Paragraph 2 provides as follows:

“ඒ අනුව සියලුම අමාත්‍යාංශ, දෙපාර්තමේන්තු සහ ඒ යටතේ වන සියලුම ආයතනයන්හි ප්‍රාථමික සේවා ගණයේ (PL-1, PL-2 සහ PL-3) දැනට පවතින සියලුම පුරප්පාඩු සඳහා බඳවාගැනීම් නැවත දැනුම් දෙන තුරු අත්හිටුවීමට 2020.01.22 දින පැවති අමාත්‍ය මණ්ඩල රැස්වීමේදී තීරණය කර ඇති අතර එකී තීරණය පරිදි කටයුතු කිරීමට පියවර ගත යුතුය.”

25. Then, by Circular No. 2/2020, dated 26.10.2020, issued by the Ministry of Finance and Policy Development, provided for the recruitment to the approved cadre of persons and filling of vacancies thereto. According to paragraph 2(viii) thereof, it provides as follows:

“ප්‍රාථමික සේවා ගණයේ (PL) තනතුරු සඳහා අවශ්‍ය සේවක පිරිස් බහුකාර්ය සංවර්ධන කාර්යසාධක බලකා දෙපාර්තමේන්තුව මගින් ලබාදීමට තීරණය කර ඇත.”

This requires that all recruitments to the PL category be made through the Multi-Purpose Development Task Force. These circulars have also been tendered by the respondents by motion dated 12.06.2023, marked once again as X-1 and X-2. The position of the respondents is that in view of the said circulars, the recruitment of the petitioners, including

those who were successful at the interviews held in 2019, could not be processed and made. Accordingly, the learned State Counsel argues that the petitioners are thus not entitled to seek employment as prayed for.

26. I will now consider this argument in the light of the events that transpired between 2019 and 2021. At the very outset, the petitioners have certainly been recruited on contract basis by the CCF for the specific purpose and object of them being employed for the purposes of the Department of Archaeology. The use of the words 'attachment' and 'absorption' clearly puts it beyond doubt that the petitioners, though recruited on contract basis by the CCF, were in fact so recruited on behalf of the Department of Archaeology, at least to the extent that the persons so recruited whilst being physically employed at various archaeological sites were intended to be so absorbed and attached to the Department of Archaeology upon the cadre approval. In these circumstances, the petitioners certainly will have the expectation of being attached and absorbed to the Department of Archaeology without any other interview or examination. However, by 4R-4 and 4R-5, there appears to have been a change that such persons may be required to face an interview. It is in view of this change of policy and procedure that the petitioners have applied and faced the interviews in 2019.

27. Up until such time, all the petitioners did have a legitimate expectation of being absorbed to the Department of Archaeology. However, the petitioners, by voluntarily submitting themselves to the 2019 interviews, have, by their act and deed of so submitting, agreed to abide by the outcome of such an interview. Therefore, the petitioners, unless they were successful in obtaining the cut-off mark, would forfeit and lose their legitimate expectation to be recruited on the strength of the original letters. However, as for the 98 petitioners who were successful, their right to be recruited on the said interview and the said legitimate expectation would continue, and they are entitled to demand that they be recruited.

28. It is thereafter that circulars No. 1/2020 and 2/2020, X-1 and X-2, submitted with motion dated 12.06.2023, come into operation. Strangely, there is a drastic change of policy as to the source of drawing persons for appointments to the category PL-1. The eligibility for recruitment is limited to those who were in the Multi-Purpose Development Task Force. By this process, the respondents have effectively disentitled and prevented the petitioners from being eligible to the said vacancies in the PL-1 to PL-3 posts. There is no reason or rationale forthcoming for this change of policy except that the persons in the said Task Force are, as claimed by the learned State Counsel, persons with some training and orientation.

29. As stated hereinabove, the petitioners in fact possessed the required qualifications, and at least a year's experience in the respective positions cannot per se be found or deemed not to have the minimum requisite aptitude or competence to be recruited to such positions. On the face of it, a sudden change of policy has certainly denied and violated the legitimate expectation of the petitioners, particularly those 98 petitioners who were successful at the interviews. The said circular No. 02/2020, along with the decision to follow the same, appears to be *mala fide*. In the absence of any express rationale or reason, it appears to be so implemented either to deliberately prevent the petitioners from being eligible or for some other extraneous reason. Even if it may not be express malice in acting so, there is, in the least, malice in law, which, according to 'Principles of Administrative Law' by Jain and Jain (8th Ed., at page 594), is as follows,

*“Mala fide exercise of power **does not necessarily imply any moral turpitude as a matter of law.** It only means that the statutory power is exercised for purposes foreign to those for which the law intended.”* [emphasis added].

Then also, Wade & Forsyth in 'Administrative Law' (11th Ed., at page 354) where the author states as follows,

*It is extremely rare for public authorities to be found guilty of intentional dishonesty: normally they are found to have erred, if at all, by ignorance or misunderstanding. **Yet the courts constantly accuse them of bad faith merely because they have acted unreasonably or on improper grounds.** Again and again it is laid down that powers must be exercised reasonably and in good faith. **But in this context ‘in good faith’ means merely ‘for legitimate reasons’.** Contrary to the natural sense of the words, they impute no moral obliquity.” [emphasis added].*

Then at page 355,

*“And Lord Greene MR...**treated bad faith as interchangeable with unreasonableness and extraneous considerations.** Bad faith therefore scarcely has an independent existence as a distinct ground of invalidity.” [emphasis added].*

30. Accordingly, on the one hand, the 98 petitioners who had a legitimate expectation of being recruited has been denied and their expectations violated. Similarly, the decision to change the policy by Circular No. 02/2020 cannot be said to have been done in good faith, and in any event, is unreasonable vis-à-vis the said 98 petitioners, as it appears that the same was for an extraneous consideration and made in bad faith, to that extent. Even if this does not necessarily imply any moral turpitude, such exercise of power is *mala fide* as a matter of law.

Conclusion.

31. Accordingly, I hold that the 98 petitioners hereinafter mentioned are entitled to the relief as follows, in respect of prayer (d). A writ of *mandamus* is accordingly issued directing the respondent 5A, the Director General of the Department of Archaeology, to appoint the 1st, 18th, 21st, 43rd, 49th, 50th, 58th, 60th, 61st, 63rd, 65th, 66th, 79th, 80th, 81st, 84th, 91st, 94th, 99th, 104th, 107th, 120th, 121st, 125th, 126th, 127th, 133rd, 142nd, 148th, 151st, 152nd, 155th, 156th, 157th, 158th, 160th, 169th, 171st, 175th, 180th, 183rd, 188th, 194th, 196th, 199th, 200th, 208th, 209th, 215th, 216th, 217th, 218th, 220th, 227th, 231st, 233rd, 235th, 247th, 251st, 253rd, 256th, 258th, 261st, 267th,

269th, 273rd, 279th, 285th, 286th, 290th, 292nd, 294th, 295th, 296th, 302nd, 306th, 315th, 316th, 317th, 322nd, 323rd, 336th, 337th, 341st, 342nd, 344th, 345th, 347th, 348th, 350th, 353rd, 354th, 356th, 364th, 366th, 384th, 386th, and 390th petitioners to the respective posts such petitioner has been successful at the interviews as depicted in X-1 and X-2. The said appointments are to be made with effect from a date preceding the date on which appointments were made to these posts, upon the cadre approval. However, the said petitioners will not be entitled to any payments of wages or other emoluments for the said period until the actual assumption of duties. However, the said period of service be considered in determining the salary, emoluments, and other entitlements as at the date of actual assumption of duties upon appointments being made as per this Judgement. The prayer seeks a *mandamus* to make the petitioners permanent in terms of the Public Administration Circulars No. 25/2014 and 29/2019. However, as relief is granted on the basis of the interviews held in 2019, *vide* X-1 and X-2, the writ is issued in the aforesaid form, which this Court is empowered and authorised to do, considering the relief that was prayed for. However, as the relief by way of *mandamus* is so granted, the consideration of relief prayed for by prayer (c) does not arise. Accordingly, the same is not granted.

32. Relief as aforesaid is hereby granted to the 98 petitioners, namely the 1st, 18th, 21st, 43rd, 49th, 50th, 58th, 60th, 61st, 63rd, 65th, 66th, 79th, 80th, 81st, 84th, 91st, 94th, 99th, 104th, 107th, 120th, 121st, 125th, 126th, 127th, 133rd, 142nd, 148th, 151st, 152nd, 155th, 156th, 157th, 158th, 160th, 169th, 171st, 175th, 180th, 183rd, 188th, 194th, 196th, 199th, 200th, 208th, 209th, 215th, 216th, 217th, 218th, 220th, 227th, 231st, 233rd, 235th, 247th, 251st, 253rd, 256th, 258th, 261st, 267th, 269th, 273rd, 279th, 285th, 286th, 290th, 292nd, 294th, 295th, 296th, 302nd, 306th, 315th, 316th, 317th, 322nd, 323rd, 336th, 337th, 341st, 342nd, 344th, 345th, 347th, 348th, 350th, 353rd, 354th, 356th, 364th, 366th, 384th, 386th, and 390th petitioners. As to the

applications of the other petitioners, they are hereby refused and rejected, as they have failed to establish a legal basis which entitles them to any relief.

33. The applications of the said 98 petitioners are allowed, and relief is granted to that extent, and of the others are dismissed. However, I make no order as to costs.

Some applications are partially allowed.
